Article IV; Section 5 from the Constitution of the Student Body.

Student Publication Committee: there shall be a Student Publications Committee composed of the editor (or two co-editors) of the <u>The Seminarian</u>, and the staff which he (she) appoints. The editor(s) should be appointed with the approval of the incumbent <u>The Seminarian</u> editor(s) whenever possible. In the event that no appointment of the editor(s) has been made by commencement the appointment of the chairman and committee shall be made in accordance with Article III, Section 1 and Article IV, Section 2. The committee shall control all student publications.

The following are proposals being made by the Editoral Committee:

- 1) Amend Section 5 to read: The committee shall control all students publication, excepting the Student Body Newsletter to the Board Members.
- 2) Of <u>The Seminarian</u> articles contributed by the Student Body to date, 19% (20 different students) have contributed at least one article. Of the total articles contributed by the Student Body 50% are contributions of the four editors. In order to present a more balanced opinion of the Student Body we recommend an alternative plan.
- 3) The alternative plan to be presented to the Student Body Meeting, by the editors of <u>The Seminarian</u>. To create a new by-law which would be included within Article IV, Section 5, that would create a committee concerned purely with the publication of a Student Body Newsletter to the Board Members. This committee would be made up of elected representative from each class, collecting data, and writing it up to be presented monthly (optional) to the Board. This will enable the opinions of the <u>entire</u> campus to be represented in contrast to the percentage which contribute to <u>the Seminarian</u>.
- a) We agree as Editors of <u>The Seminarian</u> that there does exist a gulf of communication, and that there is a need to bridge this gulf between the Board and the Student Body.
- b) The representatives (persons other thatn the class Presidents) will represent the entire class in not only, their views of seminary life, but also the personal and problematic experiences of seminary.
- c) This committee for the publication to the Boardwill have <u>sole</u> responsibility over the Student Body Newsletter to the Board Members.

From the Student Body Newsletter dated April 16, 1973

In a recent decision by the Student Body's Publication Committee, this newsletter was created in order to increase communication between students and off-campus friends and supporters. Published at least twice a year, the newsletter will attempt to inform you of the student position(s) on key issues and of current Student Body actions. The newsletterwill not attempt to discuss all student activities, opinions and decisions but will limit itself to those topics most relevant and important to you. In light of this, your constant feedback and imput is essential in insuring the success of this new communication channe.

### THE STUDENT BODY MEETING

As you all know, I have called a special meeting of the Student Body to take place on Thursday after chapel in the refectory. This decision has met with mixed emotions, I know; and everybody has enough to do otherwise, no doubt about that! In order to make this pill a bit easier to swallow, I have designated the meeting as "special," thereby dispensing with some of the parliamentary necessities of a regular meeting, i.e. reading of minutes of the previous meeting.

One aspect of the meeting will deal with the events surrounding the <u>Seminarian</u>. Since last Tuesday, the editors of the paper have been wrestling with the issue of circulation. They have met several times and conferred with several people. Now they have reached a decision and it involves an amendment to the Constitution of the Student Body - a situation which deserves our attention. The text of their proposed amendment is in another section of this issue. According to the Constitution, it cannot be voted upon, nor can it be officially presented for consideration. Rather, the purpose is to make known the intent of the editors, regarding Seminarian policy.

At the same time, there are a few other matters which should be taken care of as soon as possible. First of all, Al Martin (treasurer) has some suggestions as to what might profitably be done with a considerable sum of the Student Body funds. These suggestions will be made in the form of two motions:

- 1. That the \$300.00 plus interest which had been set aside for the purpose of purchasing the mimeo machine, and which has since been returned to operating principle, be used to purchase two electric typewriters for the Publications Committee.
- 2. That \$500.00 of the balance of operating principle be placed into a savings account at the Germantown Savings Bank.

Secondly, this meeting will provide an opportunity to vote on the amendment which I proposed at the first meeting this semester. It reads as follows:

Article VIII, Section 2 (second sentence): Officers of the second and third year classes shall be elected at the close of the preceding spring term, within one week following the last regular meeting of the Student Body.

Amendment: Officers of the second and third year classes shall be elected at the close of the preceding spring term, within one week following the conclusion of Student Body elections.

On the surface, these motions seem a bit inconsequential. But in reality, they have real importance to our seminary life. Please plan to attend so that we might take care of these issues.

#### WOMEN'S ROLE IN MINISTRY

The following are some points which were brought out during the meetings last week of the women and men interested in Women's Role in Ministry (WRM).

Several points brought up were:

- 1. Tuition structure- Does the present structure penalize those who cannot, or are not able to attend the seminary fulltime? Are there any possibilities or developments which could help those which are affected by this?
- 2. Discussing the fact that these women are entering a field which has not had the involvement of women before. Basic problems of acceptance plus the difficult task of developing a personal identity with yourself, your community, and with God. (This would be for both men and women.)
- 3. What is it about women that is unique and thus good for a ministry? The possibilities of team ministry (male/female-creating a balanced ministry.)
- 4. Our sensitivity to our own needs should not block out the needs of others.
- 5. Relationships of the family- Where does it fit into the life of a women's ministry? The family should not be last. This is a question that men should also be considering.
- 6. Should ministers be people? They must keep their humanity. Where does the single minister (male or female) fit into this? Is there any support for them? The whole question of sexuality needs to be discussed.
- 7. What is the extent of discrimination felt on campus and off?
  - a. To what extent are men furthering this?
  - b. To what extent is the curriculum discriminatory, or is it?
  - c. Does the M.A.R. program help to further any feelings of discrimination on the female candidates, by other students or the faculty cr both?
- 8. Job opportunities after seminary need to be viewed. What about the possibility of establishing some sort of opportunity on the campus for aid in obtaining either a call for the M.Div. candidates or a position for the M.A.R. candidates.
- 9. Separate/nct separate: If the women meet separately on occasion would this create a feeling of US and THEM, or would the group be open enough to understand the need for such occasional meetings?




